By combining low surface tension with a tailored rate of reaction, Protectosil BHN is able to move through the moisture boundary layer that lines the pore structure of the substrate. This permits the development of uniform gradient permeation — a consistent level of protection throughout the entire depth of penetration — allowing for longer treatment life, especially on wearing surfaces.
